## Executive Summary

This summary provides an overview of the operations, achievements, and development of the University during 2020-21. In the reporting year, the University has continued to be blessed with energetic leadership and carry on the journey of progress and advancement. Despite financial constraints, it has attained better governance with support of the statutory bodies, academic progress, and development of new infrastructure and continued smooth functioning by effectively engaged faculty, researchers, staff, and students. This has allowed the university to leap forward in pursuit of its vision and mission. Significant landmark achievements are summarised here;

- i. In the academic year 2020-21, the University has enrolled 96 PhDs, 83 M.Phil, 420 M.Sc. (Hons) Agriculture and 1873 B.Sc. (Hons) Agriculture. The University also produced 804 graduates in other BS & MBA programmes on self support basis. This also included 105 postgraduates in MS Management Science & Computer Science.
- ii. The faculty was facilitated in presenting their research in domestic and foreign conferences, and seminars. They completed and have been working on more than thirty 37 research projects won through open competitions.
- iii. Based on their research and exploration, the faculty and researchers have published quality research papers in reputed national and international journals, books, and book chapters.
- iv. The University pursued and encouraged research collaboration with organizations and institutions of higher reputation and signed MoUs during the reporting year.
- v. The faculty and researchers have also been actively involved in community services by engaging those in need of professional consultation regarding agriculture, livestock, and other allied sciences. Like research dissemination through conferences, this year too, community interactions for improvement of the agriculture and general wellbeing of the farming community have been exercised. These activities also include short term training, consultancies, and outreach activities on the farmers' fields.
- vi. The physical and technical infrastructure of the University continued to be enhanced and strengthened. Three ongoing developmental projects were being implemented, two from ADP and one PSDP during 2020-21. This includes a mega developmental project titled: "Establishment of Technology Development Centre (TDC) at the University of Agriculture, Peshawar". Similarly, establishment of Sub campus at Swat and reflection of Rs. 3000 million in the ADP for a permanent University is another landmark achievement.
- vii. Students were facilitated through scholarships, and provision of healthy environment in hostels and on campuses. They were also encouraged to participate in different co-curricular activities. However, during 2020-21 due to Covid-19 sports, dramas, debates, awareness sessions and other healthy activities normally organized by the University remain restricted and limited.

## **About The University**

Since its establishment in 1981, the University has been playing a vital role in imparting Agricultural education and conducting basic and applied agricultural research throughout the province and disseminating the research findings among the farmers and general public through various initiatives. The graduates are serving in public and private sector organizations on key positions within Pakistan and abroad.

The University has six (06) Faculties, twenty three (23) teaching Departments, Three (03) Institutes, and one (01) Centre and two sub campuses which offers Bachelor, Master, M.Phil. and PhD degrees in all disciplines of Agriculture, Animal Husbandry & Veterinary Sciences, Rural Development, Rural Sociology, Biotechnology, Management Sciences, Information Technology and Computer Sciences. All these academic programmes are run under the supervision of 395 highly qualified faculty out of which 180 hold Ph.D. degrees from leading Universities of international repute. ## **Chapter-1**

The University of Agriculture, Peshawar, after the promulgation of Khyber Pakhtunkhwa Universities Act, 2012 (Amended 2016) reframed its Statutes 2016 and got it approved from the relevant statutory bodies of the University. Currently the University is governed under its newly approved Statutes through the following statutory bodies:

#### **The Senate**

Senate has the power of general supervision over the University and shall hold the Vice-Chancellor and the authorities accountable for all the functions of the University. The Senate shall have all powers of the University not expressly vested in an Authority or Officers by the Act and all other powers not expressly mentioned in the Act that are necessary for the performance of its functions. The 7<sup>th</sup> meeting of the Senate was held on November. 26, 2020 under the chairmanship of Mr. Shah Farman, Chancellor/ Governor Khyber Pakhtunkhwa.

#### **The Syndicate**

The Syndicate is an executive body of the University which exercises general supervision over the affairs and governance of the University subject to the provisions of the Khyber Pakhtunkhwa Universities Act 2012 and Statutes 2016. During 2020-21, the following meetings were held:

## The Board of Faculty

Additionally, the board of studies also proposes curricula and syllabi for all the degrees, diplomas and certificates courses in the subject(s) concerned.

### **Selection Board**

The Selection Board is a recommending body with the mandate to consider all eligible applications for teaching and administrative positions. The Selection Board provides equal opportunities to all and recommendation/evaluation of the interviews is presented to the Syndicate for final decision. ### **Advanced Studies & Research Board (ASRB)**

The ASRB is an advisory and executing body on all matters connected with the promotion of Advanced Studies (post graduate), publication and research in the University. It is also mandated to process post graduate curricula, dissertations evaluation reports, panels of papers setters and examiners for comprehensive (written and oral) examination in light of recommendations made by the board of studies. Several Advanced Studies & Research Board meetings were held during 2020-2021 under the chairmanship of Vice chancellor. Deans and senior faculty members participated in the meetings.

### **The Finance & Planning Committee (F&PC)**

F&PC is mandated to advise on the annual statement of accounts, annual and revised budget estimates and to review periodically the financial position of the University. It advises the Syndicate on all matters relating to planning, development, finances, investment and accounts of the University. It also prepares short term and long-term academic development plans including staff and resource development.

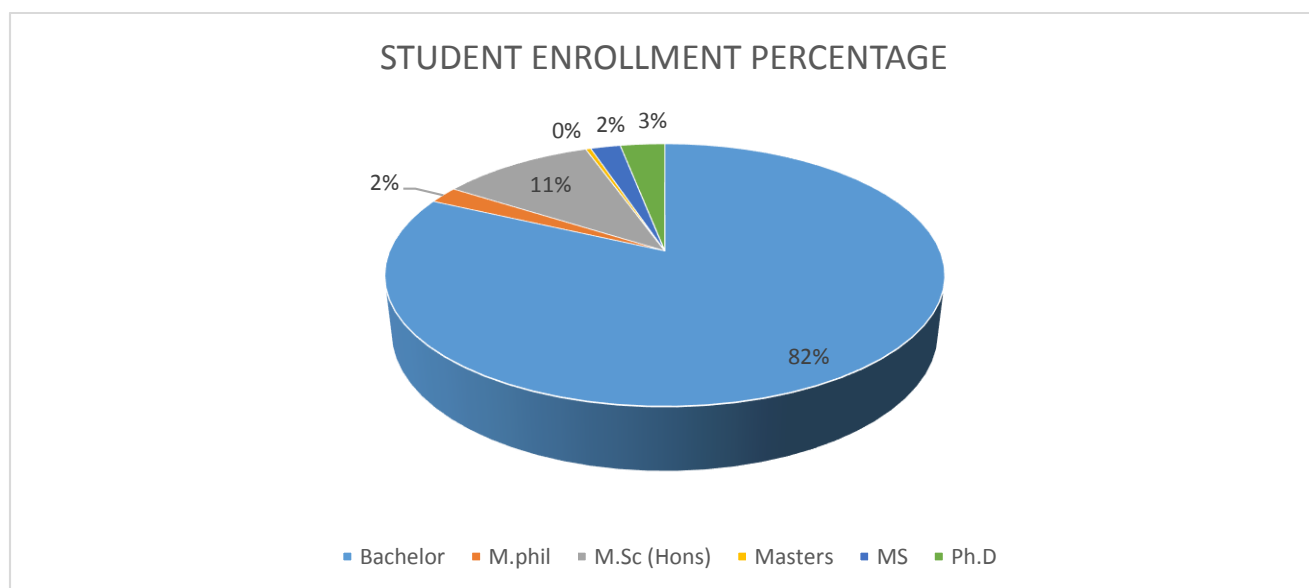
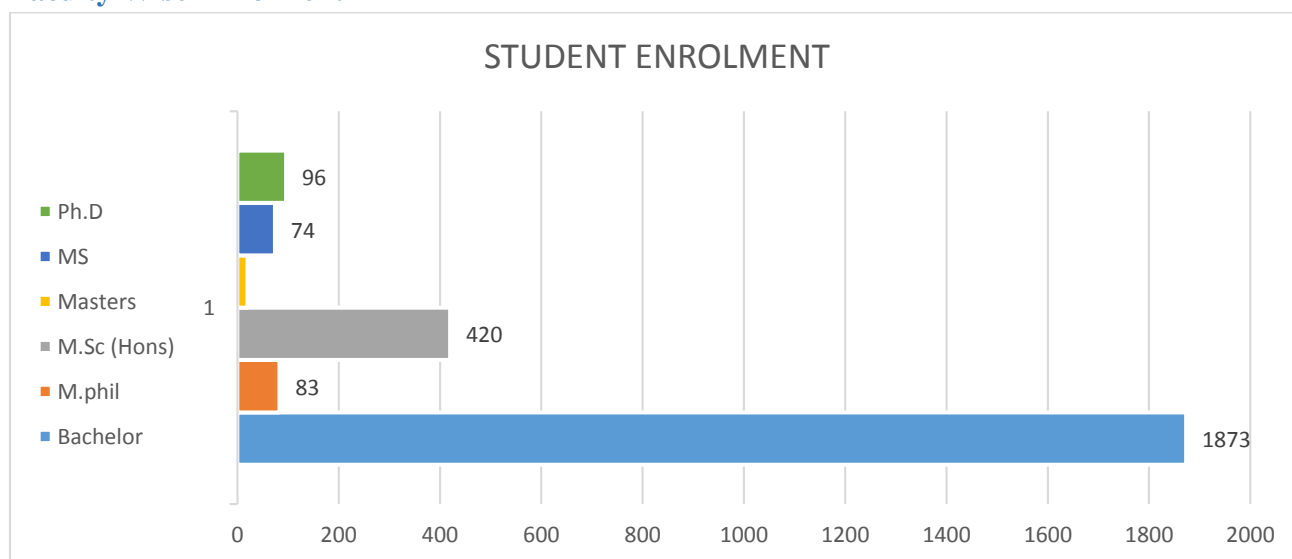

## **Chapter -4**

### **QUALITY ASSURANCE**

#### **Quality Assurance in the University**

The Quality Enhancement Cell (QEC) was established in the University under the directives of Higher Education Commission (HEC) in 2006. With the passage of time, responsibilities of the QEC increased manifold. Keeping in view the importance of the cell, the University's Syndicate acceded to upgrade the status of QEC to full-fledged Directorate of Quality Assurance (DQA).

The DQA is engaged in numerous indoor and outdoor academic activities i.e. self-assessment process, faculty and course evaluation, implementation of anti-plagiarism policy, institutional Performance Evaluation (IPE) process, facilitating in accreditation process, self IPE and postgraduate review. Currently, another task has been assigned to this Directorate that is research journals verifications and authentication for postgraduate students and faculty members.

The basic objective of the DQA is to ensure and enhance the quality of education to compete with counterparts within and across the boundaries. The Directorate is directly monitored by Quality Assurance Agency (QAA) of HEC on the basis of assigned n targets/criteria.

#### **Impact of Quality Assurance in the University**

Quality Assurance Agency of the HEC annually assesses the performance of the QECs of Higher Education Institutes against defined parameters including Institutional Performance Evaluation, Programme Self-Assessment, Accreditation of various degree programs, Postgraduate Review, functioning of Quality Assurance Directorate and implementation of HEC policies and criteria.

The Quality Assurance Directorate has developed a quality education and research culture in the University. Most of the degree programs offered by teaching departments of the University in Agricultural and allied Sciences have been accredited by the relevant Councils. Teachers' Evaluation Analysis Reports help the teachers to improve their teaching skills. The research publications of the post-graduate students and faculty were verified for awarding degrees and appointment/promotion purpose, respectively

Importantly, strict implementation of Plagiarism Policy, research work of the scholars, students theses and internship reports are put up for plagiarism test, which help in eradicating the cut-copy-paste culture from the University up to a greater extent. The authenticity of research journals is now verified by this



directorate helping faculty and students to publish their work in good quality journals rather than substandard journals.

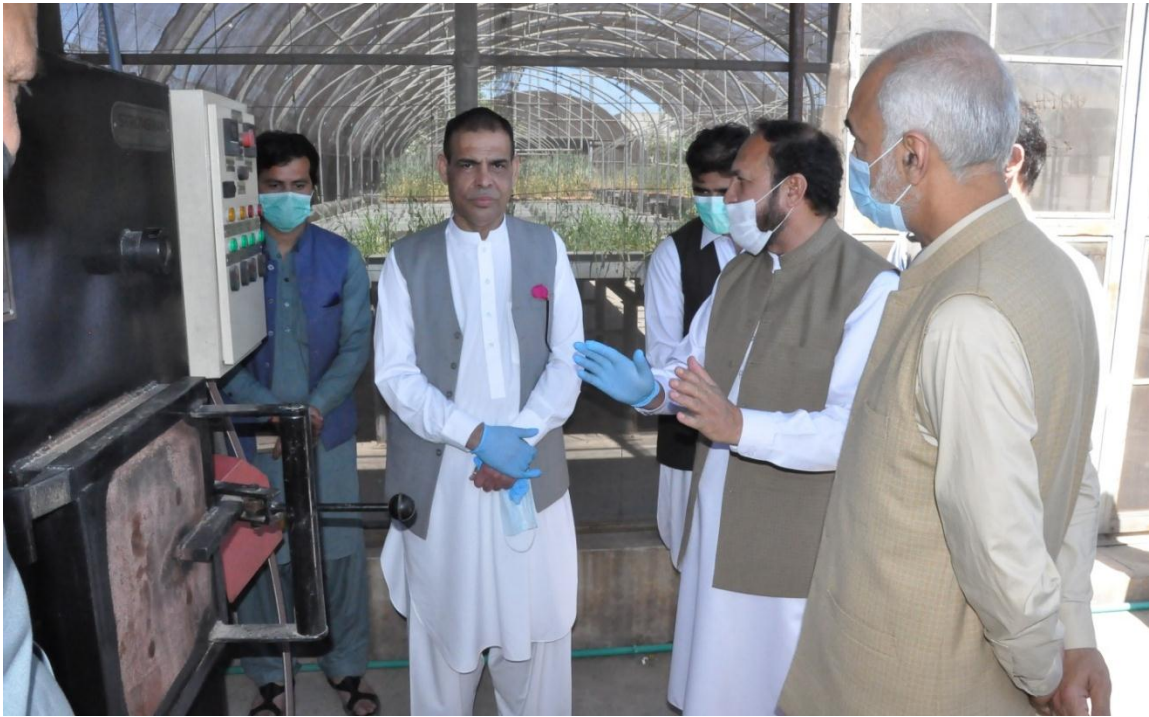

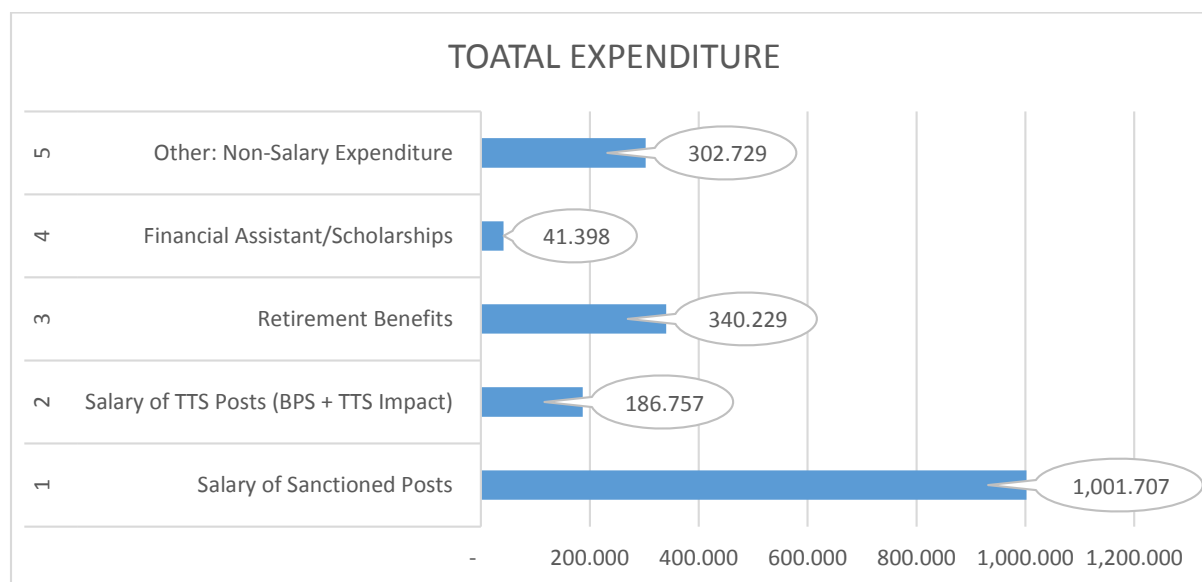
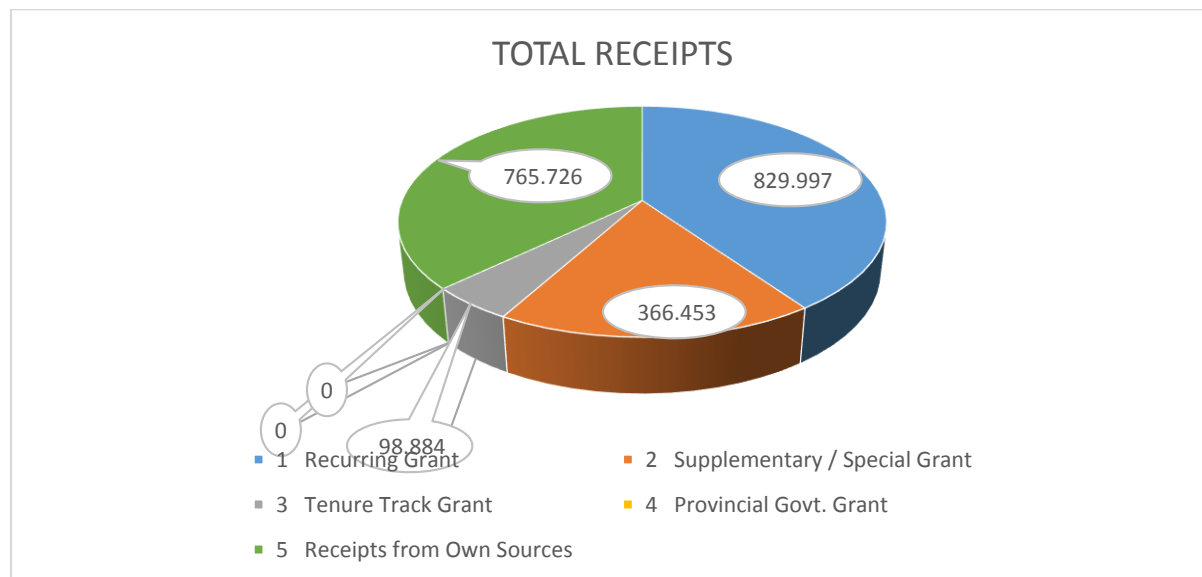
